

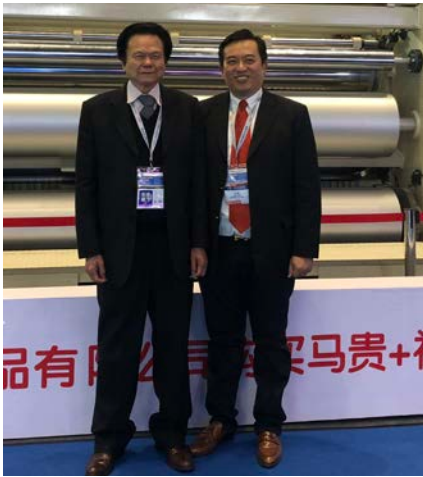

K&H manufactures complete corrugators to create corrugated sheets; some of its well-known products include the N.C. Slitter Scorer and the Positive Pressure Singlefacer.
